2. Mrs. Cleary reminded everyone to take home a copy of the publication *#LindenCelebrates*.
3. This past season our bowling team won the Watchung Conference and the wrestling team won the Mountain Conference. In addition, the bowling team won the NJSIAA Group III State Championship. We also had an individual bowler, James Fitz, who won the Individual Union County Tournament in Boys Bowling. We will honor the boys' bowling team along with Mr. Fitz at next month's meeting.

In Track, Zion Marshall won the North II Group IV State Sectional Championship in the 55-meter dash.

The boys basketball team has the 3rd seed in the State Tournament which starts next week.

She is a wonderful example for young women.
