Brendon Birch

Linden High School Student

On July 17 - 20, 2016, 20 delegates from Linden High School attended a Leadership Training Conference at the College of New Jersey sponsored by the New Jersey Association of Student Councils.

After Mr. Birch made his comments, two other students thanked the Board for the opportunity to attend this conference.

Valerie Thompson

413 W. Linden Avenue

Ms. Thompson was wondering if the 11th graders would be getting new computers this year. Dr. Robertozzi deferred to Mr. Walters who responded that they will be getting upgraded computers.

Tanya Grissett

422 So. Wood Avenue

Ms. Grissett who is the School #6 PTA President, asked for clarification on the new dress code. Dr. Robertozzi previously let her know that yes there is a policy; however, students will not be reprimanded when not in uniform. She stated that did not seem clear to her. Dr. Robertozzi responded that there is a dress code policy in each school. There are no consequences if a student fails to wear the uniform mode of dress.

Sy Mayerson

E-MAP Program Advisor

Mr. Mayerson said that he always tells his students to dress to impress and that they're doing it for their own benefit.

Lakhia Carter

135 E. Elizabeth Avenue

Ms. Carter wondered if the new dress code was something that the Board came up with and then decided to notify the parents. She remembers in the past doing surveys. She doesn't remember seeing any survey this time. Dr. Robertozzi replied that this policy was passed at two public board meetings. There will be no consequences for failure to wear the uniform, but there will be consequences for dressing inappropriately.

Mr. Topoleski interjected that basically, the younger kids were being punished for how their parents dressed them. This will alleviate that problem. Mrs. Hudak added that it was illegally implemented in the first place.

Maryann Doney School #2

Mrs. Doney asked what the consequences will be for wearing ripped jeans. Dr. Robertozzi responded that the parent would be called and asked to bring in a different pair of jeans. She replied that they have been doing just that with one particular parent all year and she totally ignores it. Dr. Robertozzi said that it is up to the principal to handle it to the best of their ability.

Tanya Grissett 422 So. Wood Avenue

Ms. Grissett said that she feels School #6 has really been disrupted. A lot of transfers came out of School #6 and there are a lot of transfers coming in. She asked where do those decisions come from? Dr. Robertozzi said that the Superintendent makes all of the recommendations and he makes them for a variety of reasons. Some of those recommendations come from the principal; some come from the employee and some are managerial prerogative. He presents his recommendation to the Board and they vote yes or no.

Valerie Thompson 413 W. Linden Avenue

Ms. Thompson told a story about a fourth grader and UNICEF and her school principal. When her daughter was in fourth grade, she found a UNICEF project she really wanted to do. Her mother suggested she speak to her principal, who at the time happened to be Dr. Roberotzzi.

Her daughter did not feel comfortable, as she felt she did not know Dr. Robertozzi. She knew her previous principals, but not Dr. Robertozzi. Ms. Thompson said she saw the project flyer go from under her daughter's pillow, to the desk, to the trash. Her point was that children need to, and do, bond with their principals and changing principals so often is not providing stability.

Randy Sautner 1206 Debra Drive

Thanked the Board for allowing students to attend the Leadership Training Conference. He also thanked Brendan Birch for helping to set it up.

He said that he received a mailing talking about backpacks and string bags. He asked if that was part of the dress code and are we banning backpacks. Dr. Robertozzi responded that it is not part of the dress code and we are not banning backpacks. Students may bring a backpack to school; however, during the day, a new rule is being implemented that the students not carry around these backpacks, but rather a string backpack when they move from class to class. This was a health and safety concern that was brought to Dr. Robertozzi's attention by the McManus Middle School nurse and also by several staff members.

Discussion ensued. Dr. Robertozzi said that this is a measure we will implement this school year. If it doesn't work, we will reevaluate.

Donna Hernandez 133 Princeton Road

Ms. Hernandez pointed out that her daughter's classes were all on the first floor while her locker was on the second. She also said that there were no lockers in the gym as the wrong size had come in, so the students had to carry their gym clothes with them every day. Her math teacher also told the students that they would be taking a lot of notes and they needed a three subject notebook. Dr. Robertozzi responded that because of the new middle school team teaching, their lockers will be by their classes. Gym lockers have been installed so that will no longer be an issue. Also, the issue of the three-ring binder will be brought up administratively as there is no longer a need for students to carry binders.

Kristi Sremcevic 9 Gresser Avenue

Ms. Sremcevic voiced her concerns about her twelve year old daughter and all the things she carries with her to class. She does not believe the string backpack can hold as much as a standard backpack.

Minutes July 26, 2016

Mr. Wohlrab said that although he did not carry a laptop while he was a high school student, he feels the string backpacks are not sturdy enough to protect the laptops. Mrs. Villani replied that this issue has already been addressed and since Soehl has been using string backpacks for several years, there is no difference in damages to laptops between Soehl and McManus. Dr. Robertozzi also replied that the laptops have a protective shell case. He believes that parents should have a say, but he also believes that when teachers, nurses and principals make a recommendation, he should listen to them.

Lakhia Carter 135 E. Elizabeth Avenue

Three of the students who went to the Leadership Training Conference won awards and Linden showed really big at the Conference.

Mrs. Hudak said that Freeholder Mirabella will be making a presentation and will invite all participants in September.

There being no further business to discuss, Mr. Topoleski made a motion to adjourn at 8:18 p.m., seconded by Mrs. Beviano. Voice vote was unanimous.
