"I would like to express my concern about a recent change in the dress code policy. I'm aware it's not on todays' agenda, but last year in the same room the board heard all the administrators speak about their support in maintaining the now old dress code policy. They spoke about the research of dress code and how it impacts school culture. Mr. Viana gave an astounding number of dress code violations as the students were given more choices in what they decided to wear at the high school level".
