Mr. Horre also attends at the end of the meetings to answer questions. There were two seniors, one junior, one sophomore and four freshmen. The students discussed the sit-in/walk-out. They commented that they were proud of their fellow classmates and amazed at how everyone participating took it seriously. Other issues of concern were also discussed. The next meeting is scheduled for April 19th.

EST for Middle School Students:

Ms. Guillaume: She asked the students what subjects they were struggling with. They responded math. They found that they had an easier time with the "Go Math" program which they had in elementary school. They stated that they were interested in subjects that would help them career-wise. They were also interested in scholarships, if available. Some concerns were that they didn't feel all of the students were taking the drills which were being implemented in the schools seriously. They would like more security, including more hall walkers. Several other concerns were discussed.
