NJSBA Delegate:

Mr. Topoleski presented the following five resolutions and asked that the Board vote to approve:

1. Resolution Opposing Use of Average Daily Attendance In the Determination of State Aid to Education:

WHEREAS, the proposed FY2014 State budget contains provisions that would require the use of average daily attendance, rather than the actual number of children enrolled in school as of October 15, to calculate state aid to education; and

WHEREAS, school districts must base their education program expenditures on the total number of students enrolled in school, regardless of attendance patterns; and

WHEREAS, school districts in which average daily attendance over a three-year period falls below 96 percent would lose significant equalization, special education and security aid through this change; and

WHEREAS, it is essential for school districts to promote student attendance, a factor in advancing academic performance and closing achievement gaps; and

WHEREAS, the use of average daily attendance in state aid distribution will reduce the resources available for programs to reduce student absenteeism, thereby working against the goal of increasing student attendance; and

WHEREAS, such a significant change in state policy should be addressed through separate legislation, and not through budgetary language. NOW, THEREFORE, BE IT

RESOLVED, that the Linden Board of Education urges the State Legislature to adopt a final budget that bases state aid distribution on the actual number of students enrolled in the school district as of October 15 and be it further

RESOLVED, that copies of this resolution be forwarded to Governor Chris Christie, Senate President Steve Sweeney, Assembly Speaker Sheila Oliver, Senate Budget and Appropriations Committee Chairman Paul Sarlo, Assembly Budget Committee Chairman Vincent Prieto, state Senator Scutari and Assembly Representatives Green and Stender; and be it further

RESOLVED, that copies of this resolution also be forwarded to the New Jersey School Boards Association and the Union County School Boards Association.

2. Solutions to School Violence Revised 2/20/2012:

WHEREAS, a prerequisite for effective learning is a safe and secure school environment; and

WHEREAS, school violence poses a direct and material threat to the safety of our children and their ability to succeed academically; and

WHEREAS, too many schools have been subject to horrific acts of violence, resulting in the injury and death of children, adolescents and school staff; and

WHEREAS, tragedies such as those in West Paducah, Kentucky, at Columbine High School in Colorado and most recently in Newtown, Connecticut underscore the need for meaningful action to address access to firearms, the delivery of mental health services, and the focus on violence in our society; and

WHEREAS, profiles of school shooters illustrate the need for a thorough examination of mental health services; and

WHEREAS, our society is saturated with depictions of violence, which desensitizes our youth; and

WHEREAS, school security is a complex issue requiring both effective responses to societal issues and the implementation of enhanced security measures in school buildings; and

WHEREAS, our school community and our community at large include individuals whose knowledge should be engaged in the search for effective responses to the issue of school violence. Now, therefore be it

RESOLVED, that the Linden Board of Education, in the County of Union, State of New Jersey urges President Obama, Congress, Governor Chris Christie and the New Jersey State Legislature to identify and implement meaningful actions that address legal access to firearms and ammunition, the delivery of mental health services, and financial support for initiatives to ensure a safe and secure school climate; and be it further

RESOLVED, that the Linden Board of Education urges the state and federal governments to provide funding for local law enforcement activities, such as the School Resource Officer program, that are directed toward youth in schools and in communities; and be it further

RESOLVED, that such action should include consultation with experts in elementary and secondary education, higher education, mental health and law enforcement; and be it further

RESOLVED, that a copy of this resolution be sent to President Obama, U.S. Senator Robert Menendez, U.S. Senator Frank Lautenberg, Representative Payne, Governor Christie, State Senator Scutari, Assembly Representative Green, Assembly Representative Stender, the New Jersey School Boards Association, and the National School Boards Association.

3. Resolution Opposing the Proposed FY 2014 SDA Assessments:

WHEREAS, beginning in Fiscal Year 2011, the State began assessing a fee equal to 15 percent of the debt service it incurred to provide construction grants to regular operating districts through the Educational Facilities Construction and Financing Act of 2000; and

WHEREAS, the so-called School Development Authority (SDA) assessment for FY2013 totaled \$20.9 million for all regular operating districts; and

WHEREAS, the proposed budget for FY2014 includes an SDA assessment of \$33.95 million, an increase of 62 percent; and

WHEREAS, for a significant number of school districts, the assessment results in a net loss in available revenue to fund educational programs; and

WHEREAS, the Educational Facilities Construction and Financing Act of 2000, at N.J.S.A. 18A:7G-14h, gives the state authority to charge only for administrative and organizational costs related to the financing of its grants; and

WHEREAS, neither the aforementioned act nor any subsequent law authorizes the state to assess fees associated with the principal and interest incurred in financing the construction grants; and

WHEREAS, the so-called SDA assessments run contrary to the stated goals of the 2000 construction act, which included providing non-Abbott districts with up-front grants to reduce the long-term debt incurred by local property taxpayers to support school construction and renovations; and

WHEREAS, the proposed FY 2014 SDA assessments are based on calculations made in December 2012 and not in January 2013, when the state's debt service payments had been substantially lowered through refinancing of some of the debt; and

WHEREAS, using the more recent estimates would result in a statewide SDA assessment of \$25.8 million for regular operating districts, a reduction of over \$8 million from the assessment included in the proposed FY2014 budget, and

WHEREAS, the state Senate and General Assembly are currently deliberating over the proposed FY2014 budget. Now, therefore be it

RESOLVED, that the Linden Board of Education urges the state Legislature to amend the proposed FY2014 state budget to relieve regular operating school districts from the burdensome SDA assessments now reflected in appropriations act; and be it further

RESOLVED, that copies of this resolution be forwarded to Governor Chris Christie, Senate President Steve Sweeney, Assembly Speaker Sheila Oliver, Senate Budget and Appropriations Committee Chairman Paul Sarlo, Assembly Budget Committee Chairman Vincent Prieto, state Senator Scutari and Assembly Representatives Green and Stender; and be it further

RESOLVED, that that copies of this resolution also be forwarded to the New Jersey School Boards Association and the Union County School Boards Association.

4. Resolution Opposing S-1191 / A-3627 (Undermining a School Board's Ability to Subcontract Services):

WHEREAS, New Jersey's boards of education represent the community's interests in the governance and budget oversight of school districts that collectively serve the health and educational needs of nearly 1.4 million children; and

WHEREAS, school boards continually strive to provide cost-effective ways to deliver services, which will free up additional funds to be used in the classroom or for propertytax relief; and

WHEREAS, many New Jersey school boards have found subcontracting of services such as transportation, cafeteria and maintenance is an option that has saved millions of tax dollars every year; and

WHEREAS, 40 percent of school districts responded to a 2009 survey conducted by the New Jersey School Boards Association, which found the responding districts saved more than \$34 million annually through subcontracting services; and

WHEREAS, Senate Bill 1191 and Assembly Bill 3627 of the 2012-2013 Legislative Session is a union-backed bill that would place severe obstacles in the way of a school board's ability to subcontract services and save tax dollars; and

WHEREAS, the sole purpose of Senate Bill 1191 and Assembly Bill 3627 is to undermine a board's ability to subcontract services, thereby increasing school employees and increasing the rolls of union membership, which generates more dues for union coffers; and

WHEREAS, Senate Bill 1191 and Assembly Bill 3627 would remove a school board's option to subcontract services, thereby diverting funds from the classroom and burdening property taxpayers.

NOW, THEREFORE, BE IT RESOLVED that the Linden Board of

Education, in its continued effort to provide cost-effective school operations to the community, opposes Senate Bill 1191 and Assembly Bill 3627; and be it further

RESOLVED, that the Linden Board of Education calls on the New Jersey Legislature to reject any such measures that will have the effect of depleting limited resources from our classroom; and be it further

RESOLVED, that a copy of this resolution shall be forwarded to members of the 22nd legislative district delegation, legislative leadership and to the Governor of the State of New Jersey, and to the New Jersey School Boards Association.

5. Resolution Opposing S-2163 and A-3696 (Requiring binding arbitration over disciplinary matters involving non-teaching staff):

WHEREAS, New Jersey's local boards of education represent the community's interests in the governance and financial oversight of school districts that serve the educational needs of nearly 1.4 million children; and

WHEREAS, Proposed legislation, Senate Bill 2163 and Assembly Bill 3696, would give non-teaching employees, such as teacher assistants, bus drivers and cafeteria aides, tenure-like protection by forcing school districts to enter into binding arbitration over non-renewal of employment, as well as virtually any "disciplinary" action, ranging from reprimands to withholding increments; and

WHEREAS, S-2163 and A-3696 would undermine the authority of local boards of education, the public's elected and appointed representatives, by preventing them from negotiating disciplinary procedures to effectively and efficiently manage employee conduct and performance; and

WHEREAS, mandated binding arbitration would require the expenditure of valuable time and resources, while placing critical decisions in the hands of arbitrators, who are not accountable to the taxpayers of the community; and

WHEREAS, S-2163 and A-3696 would subject economic decisions, such as a reduction of non-teaching staff due to a budgetary shortfall or enrollment decline, to binding arbitration; and

WHEREAS, S-2163 and A-3696 define "disciplinary action" so broadly that the term would include non-renewals of employment contracts, thereby bypassing court rulings that have consistently held that the decision not to renew fixed-term contracts of such staff does not constitute discipline; and

WHEREAS, extending binding arbitration to such "disciplinary" matters involving non-teaching staff employees will have an adverse economic impact on local school budgets at a time when school districts must make the best possible use of limited financial resources.

NOW, THEREFORE, BE IT RESOLVED that the Linden Board of Education, in fulfilling its responsibility to provide effective governance and financial oversight to our community's public schools, opposes Senate Bill 2163 and Assembly Bill 3696; and be it further

RESOLVED, that the Linden Board of Education calls on the Governor and the New Jersey Legislature to reject any and all measures that would require binding arbitration over disciplinary matters and non-renewal of employment; and be it further

RESOLVED, that copies of this resolution be forwarded to Governor Chris Christie, Senate President Stephen M. Sweeney, Assembly Speaker Sheila Y. Oliver, state Senator Scutari, and Assembly Representatives Green and Stender; and be it further
