Congratulated her son, Dylan Frank, on a job well done and let him know how very proud she is of him.

She asked if the Board has formally adopted a policy allowing students to opt out of the PARCC testing. The Board has revised their policy; however, in the New Jersey Department of Education, there is no opt out. We are not encouraging the opt out and all students are expected to take the test. If the child comes to school with a note from their parent stating that the student will not take the test, we cannot force them. The revised policy states that, if feasible, we will provide a place for that child to go during the testing. Mrs. Welsh then asked if a student does not take the test, how will that affect their future placement. Dr. Robertozzi replied that if a program within the district requires a certain score to get into that program, they will be affected. There will be other factors taken into consideration, however. One being that we do not know how the PARCC testing will be scored. Mr. Topoleski reminded her that the State does have rules and regulations governing graduation requirements also.

Mrs. Welsh reminded all Linden parents that they do have the right to refuse – their child does not have to take the test.
