WHEREAS, Mr. Shehata and the Members of the Linden Board of Education have a good faith belief that the conduct of Board Members Martucci and Kozak have engaged in conduct that is violative of N.J.S.A. 18A:12-24.15; and

WHEREAS, pursuant to the School Ethics Act, the Board is not authorized to file a Complaint with the School Ethics Commission in its own name against Board Members Martucci and Kozak; and

WHEREAS, although the Board can no longer censure a member of the Board (as that right resides exclusively with the School Ethics Commission), the Members of the Board of Education have personal knowledge of the actions forming the basis of the Complaint and believe it necessary to bring Board Member Martucci's and Board Member Kozak's ethical violations to the attention of the School Ethics Commission; and

NOW THEREFORE BE IT RESOLVED, that the Linden Board of Education authorizes the services of Special Counsel to prosecute the Complaint on behalf of Ahmed Shehata, that has been filed with the New Jersey Department of Education, School Ethics Commission, and represent him in such Complaint.

Mr. Topoleski said that last week Mr. Miranda, Supervisor of Maintenance, gave a slideshow highlighting the work that was done in each of our buildings over the summer. During the summer, Soehl M.S. auditorium was supposed to be renovated. However, it was found that there was a leak in the roof and water infiltration in the wall.
